# Evaluation of the results of physical fitness tests and legal knowledge of basketball referees in Iraq in preparation for the basketball season 2019-2020

#### Abstract

Since the basketball game is one of the group games that need psychological, physical, technical and tactical aspects, so the search for ways to succeed in these important aspects was and is still ongoing. By conducting continuous tests for them to determine their levels from all sides, and here lies the importance of the research in reaching the level of the physical and cognitive abilities of basketball referees in Iraq. The Iraqi Basketball League between the governors of the province of Baghdad and the governors of the rest of the provinces, and here lies the research problem. Their own preparations for the 2019-2020 Premier League, as well as conducting a comparative study between the governors of Baghdad governorate and the central region on the one hand and the rulers of the southern and northern regions on the other hand in physical and cognitive abilities in preparation for the 2019-2020 Premier League. The conclusions of the research There was a discrepancy in the results of the physical and cognitive abilities tests for basketball referees, as well as a slight superiority in the results of the physical tests for the rulers of Baghdad and the central region.

#### Introduction

The developed countries have recently paid attention to many aspects, including the sporting aspect, to play a role in consolidating social relations and raising the level of the country economically, socially and culturally. Which, according to the opinions of many experts in the sports field, is the second game in sequence after the widespread game of football. These three pillars are not successful for any federation in holding matches. The presence of a referee in the match is necessary and there must be neutral referees to manage the matches at all levels. Since the basketball game is one of the team games that needs psychological, physical, technical and tactical aspects, so the research was and still is Ongoing ways to succeed in these important aspects. Basketball governance needs continuous development in the psychological, physical and technical aspects, as well as the functional aspect,

- 2.1 Research Methodology

The researcher used the descriptive approach in a comparative study style for its suitability and the research problem 2-2 The research community and its sample

The research community consisted of basketball referees in Iraq, numbering 62, distributed over the governorate of Baghdad and the rest of all the governorates of Iraq. The research sample included 48 referees, 24 referees from Baghdad and the central region (international and first degree), 24 from the rest of the southern and northern governorates, and 10 referees for the pilot experiment and constituted a percentage A percentage of 77% of the original community

- 2-4-1 physical exam (PEEP)

The music tape was relied on for the physical exam (PEEPThe distance of the test is 20 m, which requires the referee to touch the lines defined by 20 m with the tone of the music. 4 Second, the referee must have high physical abilities to complete the physical test, as well as stay away from anxiety and psychological aspects that affect him and prevent him from completing the test. It causes major complications

2-4-2 Cognitive test

The cognitive test consists of 25 questions in English based on the basketball law and its interpretations. The referee must answer these questions and complete the physical test in order to be ready to manage the league matches, knowing that the test time is 30 minutes. The answer is (no) (zero) degree (yes) (2) degree, and thus the final result of the questions of the cognitive test ranges from (zero - 50) degrees, and the test questions included three axes: the duties of the technical observer, the movement of referees inside the stadium, As well as questions about special arbitration cases, as the number of questions for the technical observer was (8) questions. As for the movement of referees inside the stadium, it was (6) questions, while questions about special arbitration cases were (11) questions. Questions are sent to each laboratory via a special electronic link to be answered within a specified time, as the answer time is 30 minutes, and then the file is returned in the same way to the researcher to collect sample data for statistical processing

#### 2.5 The pilot experience:

The most important thing recommended by scientific research to obtain accurate and reliable results is to conduct the exploratory experiment, which is "a preliminary experimental study carried out by the researcher on a small sample before carrying out his research, the aim of which is to choose research methods and tools" (1) So the researcher conducted their exploratory experiment on Sunday 16/ 8/2019 on a sample of (10) judges from outside the research sample and they were randomly selected with the following objective:

- The main experiment for the rulers' tests took place in three governorates with varying dates. Tests were conducted in the city of Darbandikhan on 22/8/2019, and included the rulers of the northern region, and consisted of a physical and cognitive test within one day.
- As for the tests that took place in the People's Hall in Baghdad, on 25/8/2019, they included the rulers of Baghdad and the central region. As for the tests that took place in the city of Hilla, on 27/8/2019, they included the rulers of the middle Euphrates and the northern region

3-5 Discuss the results

Through tables (2) and table (4), which shows that there are non-moral differences between the rulers of Baghdad and the central and the rulers of the northern and southern regions in the physical test and the cognitive test. Arbitration cases and this is consistent with what Amin Al-Khouli stated that "the real success of the athlete is confirmed in the combination of practice of activity and knowledge, and that it is necessary for each athlete to be familiar with the mathematical information and knowledge that pertains to the game he is playing, and that it is not reasonable for the individual to practice the activity with confidence without ammunition from Knowledge helps him to do that, and the cognitive aspect may be the dimension separating an athlete from another athlete" (Amin, 1999). In addition, the researcher believes that it is necessary for him to have great physical abilities, as well as understanding and comprehending the articles of the law and its interpretations helps to issue correct decisions and this is consistent with the words of Amin Al-Khouli, as basketball is one of the sports, in which the success of the referee's performance is associated with theoretical and practical builders, as the referee is provided with information and knowledge that he works to integrate With what he learned previously, he achieves access to creative thinking, which is reflected during performance, especially that the rhythm of play changes, and this requires "the synergy of mental work with it and motor work in order to form a correct response to different situations" (Amin, 2000). The researcher believes that the most important elements of sports (the referee) is the practice of effectiveness and knowledge of skill and the law of the game as well as psychological and functional tactical and emotional side and this is in line with (Mohamed SobhiHassanein) makes it clear that " the true athlete 's success is confirmed in combining the practice of activity and knowledge, ie, the cognitive domain It should go hand in hand with the psychological, kinesthetic, and emotional fields, and that there is a need for every athlete to be familiar with the sports information that pertains to the game" (Mohammed, 1997).

#### Conclusions

1- There is a discrepancy in the results of the physical and cognitive abilities tests of basketball referees

2- There is a slight superiority in the results of the physical tests of the rulers of Baghdad and the central region

3- There is a noticeable superiority in the results of the cognitive test for the rulers of Baghdad and the central region

# Recommendations

1- Attention to developing the physical abilities of basketball referees in Iraq

2- Holding theoretical and practical development courses for basketball referees in Iraq

3-Working on the participation of basketball referees in external camps to increase information and develop their capabilities
